## **Lane closure on Lebuhraya Damansara-Puchong to Ease Upgrading Works on Bandar Puteri Puchong Interchange**

The upgrading works on Bandar Puteri Puchong Interchange is on schedule with a road closure planned for this weekend. Several lanes along Lebuhraya Damansara-Puchong (LDP) for northbound and southbound directions near the interchange will be closed to traffic in stages on early Saturday morning, 20 April 2019 for deck slab concrete casting works.

For motorists heading north to Kuala Lumpur/Damansara, the middle and right lanes of the LDP near the interchange will be closed from 12:01am to 5:30am. The left lane will remain opened throughout this period.

All lanes (except service lanes) on the LDP near the interchange will be closed from 12:01am to 5:30am for motorists heading south to Putrajaya/Cyberjaya. The service lanes will be closed from 2:00am to 5:30am. Traffic will be diverted as follows:

- Turn left into Lebu Puteri
- Make a U-turn opposite Giant Hypermarket
- Keep left and turn into LDP towards Putrajaya/Cyberjaya

Motorists are advised to follow directional signages placed along the LDP. Please refer to Appendix 1 on the lane closure and alternative route.

The interchange upgrade by IOI Properties Group Berhad is part of a RM63.9 million traffic enhancement project for Bandar Puteri Puchong to enhance its connectivity and improve traffic flow between the LDP and other surrounding townships.
